### There are toilets but are they used?

Out of all 932 respondents, all who had toilets, 33% gave examples of various reasons for not using the toilet always. This was the case even if over the past seven days these respondents did not go for open defecation. Out of all reasons, 16% stated that they themselves (or if the respondent was a man, the women in their household), do not use the toilet during menstruation.

### Menstruation & 55 Female Community Health Volunteers

Do those who should know, know? What do they believe, what are their attitudes to menstruation? Total 53 Female Community Health Volunteers and two men (Municipality WASH Unit staff and a community health worker) replied the survey. It was evident that knowledge was not 100% and that even health professional face taboos.

## Menstruation & 664 Students

This Brief presents the findings from a survey made among students in between 13 and 17 years old. Total 664 students responded (338 girls and 326 boys) whose teachers were also interviewed (Brief 7-2018) in five districts. There is still need to raise public debate at schools on what is truly harmful and what is not, based on what specific beliefs and practices exist. Locality but also ethnic group-wise results are very diverse. There cannot be one-fit-for-all-schools solution.


## Menstruation & 48 Teachers

This survey was responded by 48 teachers (35 men and 13 women) whose students were also interviewed (Brief 6-2018). The conclusion was that there are still very basic gaps in the knowledge, in both students and teachers. Although menstruation is included in the school curricula, we should not assume that it is covered in practice. This Brief made some suggestions for creative pedagogic ways to make students to learn. It is not only about biology but also about making it easy to talk about.

## Menstruation & 755 Adult women

This Brief focuses on adult women. A total of 755 women answered the survey. The study found that virtually all women, from all ethnic/social/caste/religious groups, are facing some level of menstruation-related discrimination. Out of this sample, 79% were defined as 'doers' in terms of always using the toilet, also when menstruating.
